3. A statement confirming or refuting the information contained in the petition regarding the unit:

- Size of Technical (TX) unit: The University's data currently reflects a headcount of approximately 4,506 employees in the TX unit. (The Petition estimated 3,989 employees.)
- **Description of the TX unit:** The TX unit is a systemwide bargaining unit of non-supervisory technical support personnel who provide technical support services for academic and scientific research throughout the University of California system.
- **Date of recognition or certification:** PERB certified UPTE as the exclusive representative for the TX unit on or about December 1, 1994.
- Approximate number of employees involved in the modification request: The University estimates that approximately 80 employees are in these title codes. (The Petition estimated 73 employees.) However, some of the employees in these title codes should be excluded from the unit because they are supervisory or managerial employees.
- The identity of any other employee organization known to claim to represent the affected employees: The University knows of no other employee organization that claims to represent these employees.
- 4. A concise statement setting forth the reasons for the support of or opposition to the unit modification proposed by the petitioner(s):

> UPTE is the exclusive representative of the TX bargaining unit at the University. Through its Petition, UPTE seeks to add title code 7343, Educational Technology Specialist 3, and title code 7352, Educational Technology Specialist 4, to the TX bargaining unit. The University does not oppose the addition of these titles, provided that any supervisory, managerial, or confidential employees are excluded as well as any employee whose principal place of employment is outside the State of California at a worksite with 100 or fewer employees. However, the University will need sufficient time to transition eligible employees.
